Dear Bahá'í Friend,

Your email letter dated 18 December 2008 regarding the potential of your entering into a management agreement with an Israeli gallery for the sale of your artwork in Israel has been received at the Bahá'í World Centre. We have been asked to inform you that there is no objection in principle to Bahá'í artists making agreements with Israeli businesses on an individual basis, and not as an organized group, to sell their work in Israel. In this regard, any such artist should be sure to make sound contractual arrangements.

Regarding your query about the portrait of the Master located outside the Council Chamber of the Universal House of Justice, it was painted by the late Reza Samimi. We take this opportunity to inform you that there is a clearly established Bahá'í policy that it is not permitted to make photographs of paintings of the Master for sale or distribution.

Regarding: Explanation for Enclosed Photo

Dearly Loved,

First, I wish to thank all you for your patience, understanding, and guidance.

Prior to your letter, I was not aware about the guidance of the Beloved Guardian in his letter of 11 July 1942*1 prohibiting the sale of photos of paintings of the Beloved Master. Thank you for raising my consciousness. My photos of Reza Samimi's painting have been pulled from circulation.

Recently, I located and scanned the original photograph that Mr. Samimi used for his painting, which is no longer protected by International Copyright laws (as is Mr. Samimi's painting).




I have restored, retouched, and colorized the original photograph. I matched Mr. Samimi's brush strokes and color palette for effect, as well as adding some of my own unique techniques in retouching the general photograph to more reflect those of the Mr. Samimi's painting. To maintain the exactness of the Beloved Master's blessed **personal essence**, I matched Mr. Samimi's color palette only to the original photograph; this was done for continuity.


For your convenience, examples of Mr. Samimi's painting, the Original Photograph, and my restoration/colorization of the original photograph follow — side by side for comparison:




Reza Samimi's painting.

I write this letter of explanation because, to the superficial observer, it is difficult to immediately differentiate between photos of Mr. Samimi's painting and my restoration, interpretive retouching, and colorization of the photograph apart from comparing the faces of our Beloved Master and some other subtle differences known only to me.

I am also writing because I wanted to alleviate any confusion. Believing the spirit of my photograph and artistic rendering conforms to your guidance as well as that which is referenced by our Beloved Guardian* I regarding the sale of photographs of The Master; I will be offering this image through my

retail outlets in Haifa, Israel also — all of whom, following the guidance in your previous letter, are well versed in the expected decorum when offering *special* images such as those of the Holy Family.

Dear Bahá'í Friend,

The National Spiritual Assembly appreciates your patience while we have sought the guidance of the Bahá'í World Centre regarding the colorization of photographs of 'Abdu'l-Bahá. As you know from previous correspondence, the general guidance governing the distribution of photos and portraits of the Master is that photographs may be distributed for purchase; drawings or paintings are to be distributed in a limited way and may not be sold. Photographs of paintings of the Master may not be distributed or sold.

There is no objection to the colorization of a photographic depiction of the Master—even though it would require certain decisions to be made by the individual that prepares the image—provided that the quality and extent of the coloring would not affect the dignity of the portrait nor violate the integrity of the original photograph. Given the accuracy and quality of your colorized reproduction of the original photograph on which Mr. Reza Samimi's portrait of the Master is based, this reproduction may be treated as a photograph. As a faithfully rendered colorized photograph, distribution and sale is permissible.

We wish you all the best in your creative endeavors on the frontiers of art and photography, in devotion to the Lord of all the Worlds.
